Pursuant to the Board's November 10, 2009 Order in the above reference matter, enclosed is the quarterly report for the Solar Loan II Program. This report covers the period from November 10, 2009 through June 30, 2022.

As of June 30, 2022, PSE&G had received a total of 1,437 loan applications for 143.1 MW of solar output. PSE&G closed 885 solar loans representing 57.6 MW of constructed solar projects. The Solar Loan II Program no longer has any loans pending.
