2. General Announcements

A. FY 2014 Program:

- i. CHP/FC
 - July 1, 2013 release of new program has been delayed. Anticipated release date August 1, 2013.





- a. Small scale projects can continue to submit existing application.
- b. Large scale projects have to wait.

ii. SBC Credit Program

- Program rules, procedures, applications, etc. under development. Anticipated release in FY 2014.
- B. Future program administrator BPU/Treasury awarded bid. No information yet on transition plan. Programs are proceeding as usual.

3. P4P Announcements

A. Partner Contact List:

B. Multiple ERP Submittals

- Many projects received lately, specifically part of ESIP, have multiple ERPs submitted for review at once. This is not an efficient method of obtaining approval.
- ii. New rule in effect immediately: For projects with multiple ERPs of similar facility and scope, please submit one (1) ERP for review and approval. All review comments and corrections can then be applied to remaining ERPs, which will greatly speed up review and approval by the program.

Q: Does this affect our recent exemption to submit a large project in phases?

A: No it doesn't affect the exemption, but if (for example) you plan to have four phases and all phases are similar facilities with similar scopes of work, you should submit the first phase ERP for review/approval, then apply all changes/comments received to remaining three phases' ERPs BEFORE submitting them to the program.

C. Form & Documents

- i. Portfolio Manager Re-Release
 - New Portfolio Manager website was launched July 17th.
 Webinars for orientation were posted on Partner LinkedIn site.

- New site seems generally user-friendly. Statement of Energy Performance, including Data Checklist and Score Card, can be easily generated under the 'Reporting' heading.
- Site-to-source ratios have been modified slightly as shown below. This will slightly lower baseline Source EUI (kBtu/sqft).

ii. ERP Tables

- For Existing Buildings the ERP Tables have been updated to reflect the new site-to-source ratios, specifically in ERP Table-1, Cell E17. <u>Please use version 3.2 of the ERP Tables for all</u> <u>projects benchmarked in the new Portfolio Manager site</u>. New ERP Tables will be available on Partner Portal.
- iii. Updated weather data and new versions of the Model Calibration (v2.12) and Savings Verification (1.7) have been posted to the partner portal.

4. Tech Topic

A. Air-Sealing

- Air-sealing supplemental calculations spreadsheet posted to partner portal. This tool <u>must be used</u> whenever air-sealing, weatherization, etc. is recommended as a measure in the P4P scope of work.
- ii. Simulation tools cannot automatically go from defined scope of airsealing work (e.g. linear feet of weather-stripped cracks) to equivalent reduction in infiltration rate. This must be calculated externally and then input into the simulation tool.





iii. Refer to attached "Air-Sealing Example.pdf"

- Table-1 'Pre-Retrofit Average Infiltration' must be supported by data obtained through on-site measurement, metering, and/or documented assumptions (e.g blower door tests).
- Table-2 must be completed for each measure. Assuming all airsealing will be bundled as one measure in the ERP, only one worksheet must be filled out. Otherwise, copy worksheet/tab to produce multiples.

Q: Are we required to use this tool on current projects?

A: We will not force you to use this tool if an ERP is already submitted, but we may recommend it during review. Otherwise, you will need to justify the approach taken to quantify air-sealing savings.

Q: Is crawl space not included because it is just an example?

A: Correct. The example is just a case study that doesn't happen to have crawl space as a line item. But the tool has a long list of air-sealing improvement types to choose from.

Air Sealing Measures - Supplemental Worksheet

Instructions

This table MUST be used if air sealing measures are included in your workscope.

Step 1 - Fill in Table 1

a) Enter whole building Pre-retrofit unadjusted Infiltration in the first row of Table 1.
b) Enter average building height and gross conditioned floor area

Step 2 - Fill in Table 2 Enter pre- and post- retrofit conditions for each measure included in the scope of work.

Select pre-retrofit description from the dropdown list in Column B, then select corresponding post-retrofit condition in Column F.

Enter quantities of each measure in the specified units.

If replacement windows or doors are selected, enter specified leakage rating in the NFRC AL column (http://www.nfrc.org/WindowRatings/Energy-Ratings.html)

Step 3 - Enter results from Table 3 | Calculated post-retrofit infilt into simulation tool

Calculated post-retrofit infiltration (unadjusted for mechanical ventilation) is shown in Table 3
