Identifying Minor and Major Deficiencies in Your CSI Registration Package

Per Board Order dated, April 17, 2024, the Board directed awarded CSI solar facilities to submit a CSI registration packet within 30 days from the effective date of the Board Order, April 24, 2024.

Pursuant to N.J.A.C. 14:8-11.5(f)1, registrations that have a <u>MINOR DEFICIENCY</u> based on the table below will be moved to an incomplete status. All parties listed in the online portal will receive an email notification which will include the missing or incorrect items that are required to be addressed. You will have <u>seven business days from the date of the email</u> to address the issue and make corrections to complete the CSI registration package. If you do not address the issue within seven business days, the registration will be rejected.

Pursuant to **N.J.A.C. 14:8-11.5(f)2**, registrations in the CSI Program that have a <u>MAJOR DEFICIENCY</u> based on the table below, will be rejected. All parties listed in the CSI online portal will receive an email notification which will identify the missing or incorrect items from your CSI registration package. Once the registration is rejected, a new CSI registration can be submitted for the project, if the date of the resubmission falls within the 30 days allowed per the Board Order. The new CSI registration will have no reference to the previously rejected registration and will be reviewed in date order received. If the revised CSI registration is submitted on or after the deadline, May 24, 2024, at 11:59:59 PM EST and is rejected a second time, the developer will no longer have the option to resubmit a new CSI registration for the awarded solar facility. Any solar facilities that received a CSI award and that were rejected on or after the date of the registration deadline, May 24, 2024, must wait 36 months plus one (1) CSI solicitation cycle after the date of the registration deadline before resubmitting the same, or substantially similar, project into another CSI solicitation.

Any solar facilities that received a CSI award and that withdrew after registration must wait at least until the expiration of the 36-month deadline for COD plus one (1) CSI solicitation cycle before resubmitting the same, or substantially similar, project into another CSI solicitation.
