Community Partners receive support in their efforts to educate their constituents about the economic and environmental benefits of clean energy and simple climate change solutions.

Why should you become a CleanPower Community Partner? CleanPower Community Partners help their residents and businesses enroll in clean energy programs that offer valuable technical assistance and financial incentives to help them reduce energy, save money, and build a cleaner, safer community and state.

2008 Clean Energy Public Outreach Campaigns: Our goal is to help Community Partners with a variety of programs for residents and businesses. We also work with Community Partners to build public awareness through 2 statewide public campaigns.

1. New Jersey CleanPower Choice Program[™]

The spring campaign is focused on increasing enrollment in the New Jersey CleanPower Choice Program. CleanPower Choice is a statewide program that gives residential and business electric customers the opportunity to support the development and expansion of renewable energy sources by paying a slight premium on their existing electric bill.

2. Change A Light Campaign

The fall campaign is focused on the Change A Light, Change The World Campaign. Each fall, **Clean**Power Community Partners are asked to encourage their constituents to join others across the state and the nation by pledging to change the 5 most commonly used lights in their home or office to ENERGY STAR[®] compact fluorescent lights.

Who can sign up for the Community Partners program?

- Community government officials, managers, environmental commissions, and department representatives (including cities, townships, and boroughs)
- Non-governmental organizations
- Colleges and universities involved in environmental initiatives
