



## PROGRAM GUIDELINES

- Applicant must be a customer of one of the following electric or gas utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G, Rockland Electric Company, New Jersey Natural Gas, Elizabethtown Gas, South Jersey Gas.
- Only select clothes dryer models purchased between July 1, 2017 and June 30, 2018 are eligible for a rebate. Please see the complete list at [NJCleanEnergy.com/DRYERS](http://NJCleanEnergy.com/DRYERS).
- Completed rebate application must be postmarked no later than 180 days from the purchase date.
- Application must be completed in its entirety, or it may be rejected. Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.
- Unit must be new and installed in New Jersey.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are subject to available funds.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements, and rebate levels are subject to change or cancellation without notice.

Tier	Efficiency Criteria	Rebate
1	Gas - CEF ≥ 3.48 Electric - CEF ≥ 3.93	\$100
2	Gas or Electric - CEF ≥ 4.30	\$300

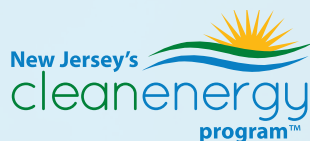
