A. CUSTOMERS – TO QUALIFY FOR YOUR REBATE, YOU MUST

- 1. Purchase, install and operate high-efficiency equipment as outlined in the table below. Abide by the rules and rebate levels in effect at the date of purchase.
- 2. Replace and/or retrofit an installation in an existing New Jersey home which is supplied with oil, propane, natural gas, IOU electric or municipal or co-op electric.
- The efficiency levels are based on the ratings found at the AHRI directory (AHRIdirectory.org) or the ENERGY STAR® listing (EnergyStar.gov).
- 4. To qualify for a furnace or boiler rebate, the installing HVAC contractor must do the following:
 - a) Size the high-efficiency equipment between 100% 140% (or 100% 200% if paired with cooling) of the calculated Manual J total heating load or equivalent and b) Meet Manual S system selection criteria.
- 5. **All units must be purchased by June 30, 2017; however all applications <u>must be postmarked within 180 days of the purchase date to be eligible</u>. Please see below "C. Important Terms and Conditions" items 1 and 2 for funding availability.**
