

# New Jersey's Clean Energy Program™

## PROGRAM GUIDELINES

- **Applicant must be a residential customer residing in New Jersey.**
- In addition to having a minimum MEF of 1.8 – 2.19, all select clothes washers must be listed by the EPA as ENERGY STAR® qualified on [NJCleanEnergy.com/arraproducts](http://NJCleanEnergy.com/arraproducts).
- Valid for select ENERGY STAR qualified clothes washers purchased between July 1, 2010 and August 31, 2010. Offer valid for a limited time only and may end before August 31, 2010 based on availability of funds. The program will terminate this promotion when funds are exhausted.
- If you purchased your qualified appliance at a retailer who offered instant rebates, you may not apply for a mail-in rebate.
- Completed rebate application must be postmarked no later than September 15, 2010.
- Rebate application must be completed in its entirety and accompanied by proof of purchase, which consists of a legible copy of a dated and itemized sales receipt.
- Rebate application must include manufacturer, ENERGY STAR model number, serial number, store name, store location, purchase date and purchase price.
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- The funding for this rebate is provided by ARRA and is intended to replace existing appliances.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are **subject to available funds**.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.

Thanks to federal stimulus funding through the American Recovery and Reinvestment Act (ARRA), *New Jersey's Clean Energy Program* is rewarding more New Jersey customers who purchase ENERGY STAR qualified clothes washers with a mail-in rebate. This offer only applies to **select** ENERGY STAR qualified models as listed on [NJCleanEnergy.com/arraproducts](http://NJCleanEnergy.com/arraproducts).

For a limited time only, get \$35 back from *New Jersey's Clean Energy Program* on the purchase of eligible ENERGY STAR qualified clothes washers with a **Modified Energy Factor (MEF) of 1.8 – 2.19**. The MEF measures energy consumption of the total laundry cycle (washing and drying). It indicates how many cubic feet of laundry can be washed and dried with one kWh of electricity; the higher the number, the greater the efficiency.

**These washers use on average 40% less energy and less water than conventional models.**
