

# New Jersey's Clean Energy Program™

## PROGRAM GUIDELINES

- Applicant must be a residential customer residing in New Jersey.
- All ENERGY STAR qualified dishwashers must be listed by the EPA as ENERGY STAR qualified on [NJCleanEnergy.com/arraproducts](http://NJCleanEnergy.com/arraproducts).
- Valid for select ENERGY STAR qualified dishwashers purchased between July 1, 2010 and August 31, 2010. Offer valid for a limited time only and may end before August 31, 2010 based on availability of funds. The program will terminate this promotion when funds are exhausted.
- If you purchased your qualified appliance at a retailer who offered instant rebates, you may not apply for a mail-in rebate.
- Completed rebate application must be postmarked no later than September 15, 2010.
- Rebate application must be completed in its entirety and accompanied by proof of purchase, which consists of a legible copy of a dated and itemized sales receipt.
- Rebate application must include manufacturer, ENERGY STAR model number, serial number, store name, store location, purchase date and purchase price.
- Compact dishwashers are not eligible for rebates.
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- The funding for this rebate is provided by ARRA and is intended to replace existing appliances.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are **subject to available funds**.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.

### ENERGY STAR Dishwashers Facts

**Save energy.** Today's ENERGY STAR qualified dishwashers use 41% less energy than the minimum federal standard.

**Hold onto your cash.** ENERGY STAR qualified dishwashers use less hot water than new conventional models, saving about \$90 over the lifetime of a unit.

**Save loads of water.** An ENERGY STAR qualified dishwasher will save about 8 gallons of water each time you wash a load of dishes compared to a pre-1994 unit.
