PROGRAM GUIDELINES

- Applicant must be a residential customer residing in New Jersey.
- All ENERGY STAR qualified refrigerators must be listed by the EPA as ENERGY STAR qualified on NJCleanEnergy.com/arraproducts.
- Valid for select ENERGY STAR qualified refrigerators purchased between July 1, 2010 and August 31, 2010. Offer valid for a limited time only and may end before August 31, 2010 based on availability of funds. The program will terminate this promotion when funds are exhausted.
- If you purchased your qualified appliance at a retailer who offered instant rebates, you may not apply for a mail-in rebate.
- Completed rebate application must be postmarked no later than September 15, 2010.
- Rebate application must be completed in its entirety and accompanied by proof of purchase, which consists of a legible copy of a dated and itemized sales receipt.
- Rebate application must include manufacturer, ENERGY STAR model number, serial number, store name, store location, purchase date and purchase price.
- Compact refrigerators are not eligible for rebates.
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- The funding for this rebate is provided by ARRA and is intended to replace existing appliances.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are **subject to available funds**.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.

ENERGY STAR Refrigerator Facts

If you still have a fridge from the 1980s, replace it with an ENERGY STAR qualified model and save over \$100 each year on your utility bills. Replace a fridge from the 1970s and save nearly \$200 each year!

Qualified Specifications for Refrigerators

Tiers	ENERGY STAR Criteria	ARRA Rebate
1	20% better than Federal standard	\$75
2	25% better than Federal standard	\$100

The refrigerators have to be 7.75 cubic feet or greater in volume for both the \$75 and \$100 rebates.
