 - i. Table-2 no longer rounds, calculates incentive to the penny
 - ii. Incentive calculations revised slightly to reflect program guidelines and filing (rounding/percentage).
 - iii. These tables <u>must be submitted for all new Proposed ERP (Rev0)</u> received <u>May 1st and onward.</u> May be used on existing projects in pipeline.

2. Fiscal Year 2016 Programs

- A. Proposed program changes will be circulated for comment in the coming weeks.
 - i. P4P EB:
 - 1. Eliminate minimum IRR requirement
 - 2. Increase minimum size to participate to 200 kW
 - 3. Eliminate kW waiver
 - 4. Extend 4% savings to hospitals and create tiered incentive structure
 - 5. Increase cap on lighting savings from 50% to 70%; will increase minimum savings requirement by one percent point for each percent over 50%.
 - 6. Prohibit participation in other NJCEP programs while doing P4P for the same facility
 - 7. Allow TRC to complete expedited pre-inspections upon receipt of ERP Tables with minimum required information. Does not apply to spot inspections (single equipment replacement)
 - 8. Reduce revision turn-around time from 90 days to 30 days
 - 9. Continue to develop alternative path that includes Environmental Defense Fund's Investor Confidence Project (ICP) integration





ii. P4P NC:

- 1. Eliminate IRR requirement
- 2. Eliminate square foot waiver
- 3. Increase cap on lighting savings from 50% to 70%; will increase minimum savings requirement by one percent point for each percent over 50%.
- 4. Prohibit participation in other NJCEP programs while doing P4P for the same facility
