  - i. Note that there is a glitch in the parametric run tool of this software which results in data modification categories to be missing.
  - ii. This can be overcome by editing expressions within the text editor of "\*.prd" file (not via user interface) with the model closed, saving the "\*.prd" file, and then opening and running calculations for all parametric runs within eQUEST interface.
