



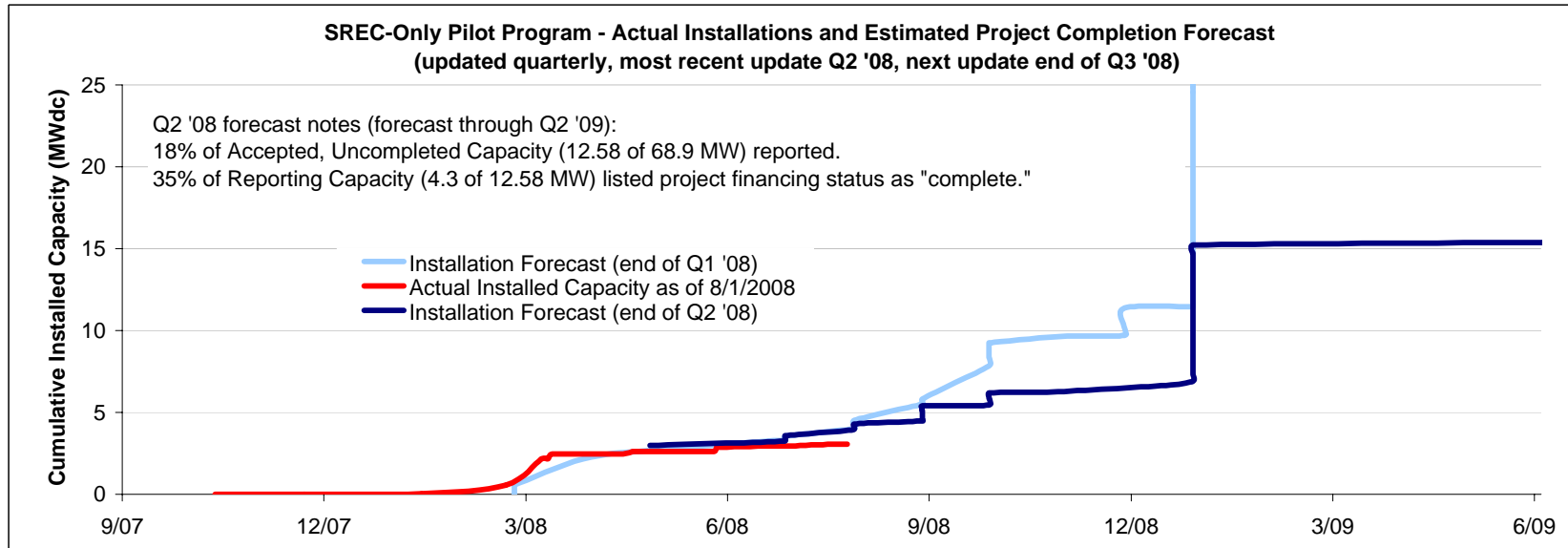

6. Final Reg Accepted - A final registration package has been determined to comply with all program requirements, and an NJCEP inspection of the system can be scheduled.
7. Passed Inspection - A proposed system has passed its NJCEP inspection.
8. Submitted to SREC Admin - System data has been submitted to the SREC Administrator to enable creation of an SREC account.
9. Denied - A registration that is denied by the Program Manager for any reason.
10. Expired - A registration that has expired (for example, the registrant has not completed construction with the 9 or 12 month period allowed).
11. Withdrawn - A registration that is voluntarily withdrawn by the registrant.
12. Hold - A registration on hold by the Program Manager pending clarification of program requirements.
