- In addition to being ENERGY STAR qualified, washers must meet or exceed Consortium of Energy Efficiency Tier 2 requirements of MEF of 2.2 or greater. Please see NJCleanEnergy.com/CLOTHESWASHERS for a list of eligible ENERGY STAR qualified washers.
- Valid for select ENERGY STAR qualified clothes washers purchased between January 1, 2013 and June 30, 2013.
- Completed rebate application must be postmarked no later than July 31, 2013.
- Application must be completed in its entirety. If the application is not completed in full, your application may be rejected for a rebate.
- Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from *New Jersey's Clean* Energy Program (NJCEP) and are subject to available funds.
