

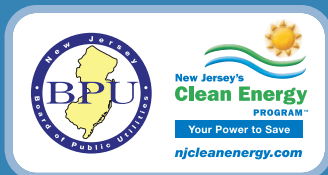
PROGRAM GUIDELINES

- Applicant must be a customer of one of the following electric or gas utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G Electric, Rockland Electric Company, New Jersey Natural Gas, Elizabethtown Gas, PSE&G Gas, South Jersey Gas.
- In addition to being ENERGY STAR qualified, washers must meet or exceed Consortium of Energy Efficiency Tier 2 requirements of MEF of 2.2 or greater. Please see NJCleanEnergy.com/CLOTHESWASHERS for a list of eligible ENERGY STAR qualified washers.
- Valid for select ENERGY STAR qualified clothes washers purchased between July 1, 2013 and June 30, 2014.
- Completed rebate application must be postmarked no later than July 31, 2014.
- Application must be completed in its entirety. If the application is not completed in full, your application may be rejected for a rebate.
- **Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.**
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are subject to available funds.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.

The modified energy factor measures energy consumption of the total laundry cycle (washing and drying). It indicates how many cubic feet of laundry can be washed and dried with one kWh of electricity; the higher the number, the greater the efficiency.
