- Applicant must be a customer of one of the following electric or gas utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G Electric, Rockland Electric Company, New Jersey Natural Gas, Elizabethtown Gas, PSE&G Gas, South Jersey Gas.
- In addition to being ENERGY STAR qualified, washers must meet or exceed Consortium of Energy Efficiency Tier 2 requirements of MEF of 2.2 or greater. Please see NJCleanEnergy.com/CLOTHESWASHERS for a list of eliqible ENERGY STAR qualified washers.
- Valid for select ENERGY STAR qualified clothes washers purchased between July 1, 2014 and March 31, 2015.
- Completed rebate application must be postmarked no later than April 30, 2015.
- Application must be completed in its entirety. If the application is not completed in full, your application may be rejected for a rebate.
- Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from New Jersey's Clean Energy Program (NJCEP) and are subject to available funds.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
