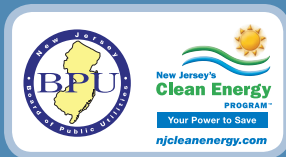
PROGRAM GUIDELINES

- Applicant must be a customer of one of the following electric or gas utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G, Rockland Electric Company, New Jersey Natural Gas, Elizabethtown Gas, South Jersey Gas.
- Only select ENERGY STAR certified clothes washers are eligible for a rebate. Please see the complete list at NJCleanEnergy.com/CLOTHESWASHERS.
- If you received an instant rebate from a retailer, you are not eligible for the mail-in rebate.
- Valid for select ENERGY STAR certified clothes washers purchased between July 1, 2014 and June 30, 2015.
- Completed rebate application must be postmarked no later than 180 days from the purchase date.
- Application must be completed in its entirety. If the application is not completed in full, your application may be rejected for a rebate.
- **Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.**
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are subject to available funds.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.

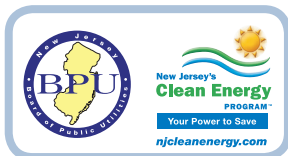
