

# New Jersey's Clean Energy Program™

## PROGRAM GUIDELINES

- Applicant must be a customer of one of the following electric or gas utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G Electric, Rockland Electric Company, New Jersey Natural Gas, Elizabethtown Gas, PSE&G Gas, South Jersey Gas.
- Customers of municipal electric utilities do not qualify for a rebate.
- In addition to having a minimum MEF of 2.2, all select clothes washers must be listed by the EPA as ENERGY STAR® qualified on [NJCleanEnergy.com/clotheswashers](http://NJCleanEnergy.com/clotheswashers).
- Valid for select ENERGY STAR qualified clothes washers purchased between January 1, 2012 and December 31, 2012.
- Completed rebate application must be postmarked no later than January 31, 2013.
- Application must be completed in it's entirety. If the application is not completed in full, your application may be rejected for a rebate.
- Rebate application must include manufacturer, ENERGY STAR model number, serial number, store name, store location, purchase date and purchase price.
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- **Rebate request must be accompanied by a legible valid proof of purchase, which specifies a purchase date, item(s) purchased, and indicates it is paid in full or under financing.**
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are **subject to available funds**.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
