

PROGRAM GUIDELINES



- Applicant must be a customer of one of the following utilities:
 - Atlantic City Electric
 - JCP&L (First Energy)
 - PSE&G
 - Rockland Electric Company
 - New Jersey Natural Gas
 - Elizabethtown Gas
 - South Jersey Gas
- Only select clothes washer or clothes dryer models purchased between July 1, 2019 and June 30, 2020 are eligible for a rebate. Please see the complete list at NJCleanEnergy.com/WASHERS and NJCleanEnergy.com/DRYERS.
- Some retailers provide instant rebates at the register at the time of purchase. If you received the instant rebate, you are not eligible for this mail-in rebate. For a list of retailers that provide instant rebates, go to NJCleanEnergy.com/RETAILERS.
- An application must be filled out for each appliance.
- Completed rebate applications must be postmarked no later than 180 days from the purchase date.
- Application must be completed in its entirety, or it may be rejected. Rebate request must be accompanied by a **legible sales receipt**, which specifies the purchase date, item purchased, and indicates it is paid in full.
- Unit must be new and installed in New Jersey.
- Rebates are issued in the form of a check from New Jersey's Clean Energy Program (NJCEP) and are subject to available funds.
- Please allow 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements, and rebate levels are subject to change or cancellation without notice.
