

New Jersey's Clean Energy Program Recycle & Win! Contest Official Rules

Contest Description: NO PURCHASE NECESSARY TO ENTER OR WIN; PURCHASING WILL NOT INCREASE YOUR ODDS OF WINNING. The Recycle and Win Contest ("Contest") is open to legal residents of the U.S., residing in areas of the state served by *New Jersey's Clean Energy Program* and age 18 or older. Entrants must have a current residential electric account with a New Jersey Electric Distribution Company (EDC) at the time of entry. The Contest will recognize and reward the entrants who recycle refrigerators or freezers ("Winning Entries") within the areas of the state served by *New Jersey's Clean Energy Program* as part its Refrigerator/Freezer Recycling Program ("Recycling Program") during the spring cleaning season. The Contest will run from April 1, 2013 through May 31, 2013 ("Contest Period"). Contest winners will be selected by random drawing by June 17, 2013.

The New Jersey Board of Public Utilities (BPU) will recognize four winners.

The contest is administered by JACO Environmental, Inc (JACO or administrator). JACO is responsible for administering energy efficiency appliance recycling programs for the BPU. JACO maintains an advanced appliance recycling center in New Jersey.

How to Enter, Qualifications, and Eligibility – Entrants must have a refrigerator or freezer collected or call to schedule a pick-up to recycle a refrigerator or freezer ("Appliances") through the Recycling Program during the Contest Period. Entrants must comply with all rules and requirements of the Recycling Program explained below. Entrants may recycle no more than two Appliances. Appliance(s) must be owned by entrants. All Appliances collected as part of the Recycling Program during the Contest Period will automatically be entered into the Contest.

All Appliances including the Winning Entries will be recycled through the Recycling Program. *In order to be eligible for the Contest, each Appliance must meet the following requirements:*

- Appliance must be collected from a residential address with an active residential electric account through an EDC. The refrigerator(s) and/or freezer(s) must be owned by the program participant. Units located in commercial properties are not eligible.
- Appliances must be a minimum of 10 cubic feet and maximum of 30 cubic feet in internal dimensions.
- Appliances must be in working order.

As noted above, all Appliances collected during the Contest Period or collected pursuant to customer enrollment/scheduling a refrigerator or freezer pick-up during the Contest Period will be automatically entered into the Contest. Owners of Winning Entries will be asked to sign a release of liability regarding use of the Winning Entries and their stories for publicity purposes.

Employees, officers, directors and agents and program implementation contractors of the BPU, their immediate family members and persons living in their same household, are not eligible to participate in the contest. Void where prohibited. All federal, state and local laws and regulations apply.

Prize - Each winning entrant will receive one of four \$500 prepaid debit cards to spend as he/she determines, for example, towards the purchase of ENERGY STAR[®] qualified products ("Prize") if the winner desires. No substitution, cash redemption (except as provided herein) or transfer of Prize (or any portion thereof) permitted by winners. The BPU and JACO reserve the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole discretion. In no event will more than the stated number of prizes be awarded. All costs and expenses associated with the acceptance and use of the Prize not specifically stated in these Official Rules as being provided (including, but not limited to federal, state and local taxes) will be the sole responsibility of the winner. All prize details are at the BPU and JACO's sole discretion. Prizes will be shipped approximately 6-8 weeks from receipt of winner claim information and verification.

Determining the Winner – Contest Winners will be determined by a random drawing. Drawing will be conducted by the BPU's program manager in the presence of BPU personnel.

Odds of winning depend on the total number of valid entries received. The potential winners will be sent an e-mail or, in the event the BPU or JACO does not have potential winners' e-mail addresses or e-mails are returned as undeliverable, then the BPU or JACO will attempt to contact potential winners by telephone. If potential winners cannot be reached within 48 hours of the first e-mails and/or phone call attempts, then potential winners may be disqualified, at the BPU's sole discretion.

Potential winners will be required to provide their full name, address, city, state, zip code, date of birth and phone number (including area code), and to complete additional documents requested, if any, to claim his/her prize. The potential winners may be required to sign and return an Affidavit of Eligibility and receipt, and a Model Release. Potential winners will have fourteen (14) business days from e-mail or phone notification to provide required information or the Prize may be forfeited and awarded to an alternate winner from among all eligible remaining entries received. E-mail notification shall be deemed to have occurred on the date the BPU or JACO's designees' first attempt to make e-mail contact with a potential winner. If potential winner is found to be ineligible for any reason, an alternate winner may be selected, at the BPU's or JACO's sole discretion. If Prize is returned as undeliverable, it will result in disqualification, and the Prize may be awarded to an alternate winner. Any non-response by potential winner, or BPU's or JACO's failure to receive required documentation from potential winner within the prescribed fourteen (14) business day period will result in disqualification and the selection of an alternate winner, at the BPU's or JACO's sole discretion. In the event the BPU or JACO is unable to contact a potential winner, or if a potential winner is non-compliant with these Official Rules, the potential winner will be disqualified and an alternate winner may be selected. The BPU and JACO are not responsible for unsuccessful efforts to notify potential winners.

General Conditions – The BPU reserves the right to halt the Contest at any time for any reason whatsoever including but not limited to situations beyond its control, such as regulatory or other government action effecting the energy efficiency program delivery, strikes, acts of God, etc., or for any reason. The BPU reserves the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Contest. The BPU reserves the right to cancel this Contest at any time without obligation or prior notice. By entering, each entrant agrees to be bound by these Official Rules and the decisions of the BPU, which shall be final. Each entrant understands and agrees that they will not receive their

appliance back regardless of whether or not the entrant's appliance is a Winning Entry. Each appliance will be recycled through the Appliance Recycling Program.

Release and Indemnification - By participating in the Contest, each entrant agrees to release, defend, indemnify and hold harmless the BPU, JACO and their respective parents, affiliates, subsidiaries, divisions, suppliers, and/or advertising or promotion agencies, individuals or entities responsible for the development, printing, distribution and implementation of this Contest from and against any and all claims, demands, expenses, losses and liabilities of any nature whatsoever caused or contributed by entering or participating in the Contest. By participating in the Contest, entrant irrevocably grants to the BPU and their designees, the unconditional and perpetual right and permission to copyright (as appropriate), reproduce, encode, store, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and/or otherwise use or reuse, without limitation, the entrant's name, city and state, image, voice, likeness, statements, biographical material as well as any additional photographic images, video images, portraits, interviews or other materials relating to the entrant and arising from his/her participation in this Contest in any and all media now known or hereafter devised, throughout the world in perpetuity, for any purpose, without limitation and without additional review, notification, compensation, or approval from the entrant (unless prohibited by law).

Disputes: By entering the Contest, entrants agree that (a) any and all disputes, claims, and causes of action arising out of or connected with the Contest, or any prize awarded, shall be resolved individually, without resort to any form of class action; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event attorneys' fees; and (c) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim punitive, special, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than for actual out-of-pocket expenses.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the BPU, JACO and their respective subcontractors in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of New Jersey, without giving effect to any choice of law or conflict of law rules (whether of the State of New Jersey or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New Jersey. Venue with respect to any disputes shall be had in the state and federal courts of the State of New Jersey.
