PROGRAM GUIDELINES

- Applicant must be a customer of one of the following electric utilities: Atlantic City Electric, Jersey Central Power & Light, PSE&G Electric, Rockland Electric Company.
- In addition to being ENERGY STAR qualified, refrigerators must be 25% or better than the federal standard as listed on NJCleanEnergy.com/FRIDGEREBATE.
- Valid for select ENERGY STAR qualified refrigerators purchased between July 1, 2014 and September 30, 2014.
- Completed rebate application must be postmarked no later than October 31, 2014.
- Refrigerators must be 7.75 cubic feet or greater to qualify for the rebate.
- Application must be completed in its entirety. If the application is not completed in full, your application may be rejected for a rebate.
- Rebate request must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full or under financing.
- The manufacturer model number and serial number can be found on the unit itself (do not copy from the receipt or box).
- Compact refrigerators are not eligible for rebates.
- Limit one rebate per customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- Rebates are issued in the form of a check from *New Jersey's Clean Energy Program* (NJCEP) and are subject to available funds.
- Please allow up to 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
