A. CUSTOMERS - TO QUALIFY FOR YOUR REBATE, YOU MUST

- 1. Purchase, install and operate high-efficiency equipment as outlined in the table below.
- 2. Replace and/or retrofit an installation in an existing New Jersey home which is supplied with natural gas, oil, propane, IOU (public) electric, or municipal or co-op electric.
- 3. A list of qualifying systems can be found at energystar.gov.
- 4. Solar Domestic Water Heater (SDW) must be installed by a contractor with a New Jersey Home Improvement Contractor's (HIC) License, participating in the SDW Program.
- 5. **All units must be purchased by July 31, 2017; however all applications <u>must be postmarked within 180 days of the purchase date to be eligible.</u>
 Please see below "C. Important Terms and Conditions" items 1 and 2 for funding availability.**

C. IMPORTANT TERMS AND CONDITIONS

- 1. This program is based on availability of funds. Procedures, requirements and rebate levels are subject to change and the program is subject to cancellation without notice.
- 2. Funding for this rebate program for oil, propane, municipal and co-op electric customers is provided through the United States Department of Energy State Energy Program (SEP) and is subject to closure at any time.
- 3. Due to the limited availability of funds, the program will terminate **when funds are exhausted or July 31, 2017**, whichever comes first. Notice will be posted on **NJCleanEnergy.com**.
- 4. It is the responsibility of the customer to assure that all requirements for the rebate are met and that all required documentation is provided. Failure to provide any of the required information will prevent processing of your application.
- 5. Rebate eligibility will be based on the equipment purchase date.
- 6. Incentives are available for the installation (retrofit) of qualified HVAC and/or water heater equipment in existing residential buildings; newly constructed homes are not eligible.
- 7. Please allow up to 120 days from the date NJCEP receives all required information to process your rebate.
- 8. NJCEP reserves the right to inspect all installations in order to ensure compliance with all program requirements.
- 9. NJCEP provides no oversight or control over any contractor services related to this program. Responsibility for proper sizing of equipment, as well as delivery and workmanship related to any equipment or services the customer procures, rests exclusively with the contractor selected by the customer. NJCEP assumes no responsibility for oversight of contractor services.
- 10. NJCEP audits its rebate programs as a protection against consumer and/or contractor fraud. Any attempt to defraud NJCEP will result in automatic rejection of the rebate application and possible legal action.
- 11. Contractors are required to comply with state and local plumbing, electrical and building codes and regulations and other requirements applicable under federal, state and local authority.
- 12. Customers participating in other programs within NJCEP or New Jersey Weatherization Assistance Programs may not be eligible for rebates.
- 13. For Solar Water Heater Installers/Contractors:
 - Contractors must be listed as a participating contractor under the NJCEP Solar Domestic Water Heater Program.
 - Contractors are required to have prior industry experience with Solar Domestic Water Heater (SDHW) installations and have completed either an Interstate Renewable Energy Council (IREC) accredited or manufacturer SDWH training.
 - · Contractors have to meet minimum training requirements, follow manufacturer installation guidelines and provide warranty service as specified by the program.
 - Contractors must provide the customer with a signed, completed Solar Water Heating Self-Inspection System Checklist.
 - · The system must be climate appropriate.
 - NJCEP reserves the right to remove any contractor or manufacturer from the approved list for activities or communications that NJCEP determines to not be in the best interests of the SDW Program or of NJCEP.
