New Jersey's Clean Energy Program is offering customers who are replacing equipment/appliances in a home or business damaged by Hurricane Sandy enhanced incentives when purchasing high efficiency equipment. These enhanced incentives are in addition to current incentives in place for purchasing high efficiency equipment.

All customers requesting increased incentives due to damage caused by Hurricane Sandy are required to submit a signed certification form.

Customer's place of residence should be located in a Sandy designated area (see eligible zip code list) or if your residence is outside of the zip code list, you may qualify for increased incentives by demonstrating that you experienced damage caused by Hurricane Sandy. Applications for Hurricane Sandy relief incentives will be reviewed on a case by case basis. Please contact 866 NJ-SMART for additional information.
