Instructions: Please read the program instructions, terms and conditions before completing the form on the other page.

A. CUSTOMERS – TO QUALIFY FOR YOUR REBATE, YOU MUST

1. Purchase, install and operate a high-efficiency furnace, boiler and/or domestic hot water heater in a residence that is currently supplied with gas directly from Elizabethtown Gas, New Jersey Natural Gas, Public Service Electric & Gas or South Jersey Gas.
2. Replace and/or retrofit an installation in an existing New Jersey home.
3. The efficiency levels are based on the Air-conditioning, Heating, Refrigeration Institute (AHRI) ratings found at the www.AHRIdirectory.org website. All ENERGY STAR® qualified equipment must be listed at www.energystar.gov in order to participate in this program. Conversion burners are not eligible.
4. Abide by the rules and rebate levels in effect at the date of purchase.
5. **Postmark the application within 120 days of purchase date.**

Gas Furnace with ECM*	AFUE 92% or greater and ENERGY STAR qualified	\$400
Gas Boiler	AFUE 85% or greater and ENERGY STAR qualified	\$300
Domestic Gas Hot Water Heater	EF* .82 or greater	\$300

*AFUE (Annual Fuel Utilization Efficiency), ECM (Electronically Commutated Motor), EF (Energy Factor)

1. This program is based on availability of funds. Procedures, requirements and rebate levels are subject to change and the program is subject to cancellation without notice.
2. It is the responsibility of the customer to assure that all requirements for the rebate are met and that all required documentation is provided.
3. Failure to provide any of the required information will prevent processing of your application.
4. Rebate eligibility will be based on the equipment purchase date.
5. Incentives are available for the installation of qualified HVAC equipment in all existing residential buildings (retrofit).
6. Installations of equipment in new homes are not eligible for incentives.
7. Please allow up to 120 days from the date *New Jersey's Clean Energy Program* receives **all required information** to process your rebate.
8. To expedite the processing of your application, please provide an AHRI reference number for installed system.
9. If the customer portion of the rebate is to be assigned to another party, the customer must authorize this by completing and signing section B of the application form.
10. *New Jersey's Clean Energy Program* reserves the right to inspect all installations in order to ensure compliance with all program requirements.
11. *New Jersey's Clean Energy Program* provides no oversight or control over any contractor services related to this program. Responsibility for proper sizing of equipment, as well as delivery and workmanship related to any equipment or services the customer procures, rests exclusively with the contractor selected by the customer. *New Jersey's Clean Energy Program* assumes no responsibility for oversight of contractor services.
12. *New Jersey's Clean Energy Program* audits its rebate programs as a protection against consumer and/or contractor fraud. Any attempt to defraud *New Jersey's Clean Energy Program* will result in automatic rejection of the rebate application and possible legal action.
13. Installations must be completed in accordance with all laws, codes and other requirements applicable under federal, state and local authority.
14. Customers participating in other programs within *New Jersey's Clean Energy Programs* or New Jersey Weatherization Assistance Programs may not be eligible for rebates.
