



New Jersey's Clean Energy Program Solar Renewable Energy Certificates (SRECs) Program

Major System Change Form

Once enrolled in the SRECs program, system owners (or their authorized agents/aggregators) are responsible for reporting any changes to the ownership or total capacity of their system, or changes that affect the metering of energy produced by their system. Generally, there are four types of changes that must be reported:

1. Changes in system ownership (for example, a property with an installed solar energy system is sold to a new owner);
2. Changes in system location (a system is moved from one property to another)
3. Changes in the rated capacity of the system (for example, new solar panels are added to or removed from an existing system);
4. Changes to equipment used for metering the system (for example, replacement of a meter or inverter).
