Pursuant to the Board's November 10, 2009 Order in the above reference matter, enclosed is the quarterly report for the Solar Loan II Program. This report covers the period from November 10, 2009 through September 30, 2014.

As of September 30, 2014, PSE&G had received a total of 1,437 loan applications for 144.12 MW of solar output. PSE&G closed 885 solar loans representing 58.62 MW of constructed solar projects. The Solar Loan II Program no longer has any loans pending.

- (3) Increase in PSE&G Internal Labor from September 2012 forward is due to reclassification of contractors to Project Employees
- (4) Includes PSE&G employees only
