Renewable Energy Compliance Certification Forms For the State of New Jersey

INSTRUCTIONS

New Jersey's renewable energy portfolio standards at N.J.A.C. 14:8-2.5(h) and 2.6(g)(2iii) require TPS/BGS Providers (load serving entities) and Class I and II renewable energy generation facility operators to file an annual affidavit with the Board of Public Utilities certifying that their generating facility continues to operate in conformity with their respective sections. Affidavit forms that must be used to show compliance with these requirements are attached on pages 2-3.

There are two forms attached:

- The Class I Renewable Energy Certification form is for TPS/BGS
 Providers or facility operators that generate electricity through the use of Class I renewable energy from biomass.
- The Class II Renewable Energy Certification form is for TPS/BGS
 Providers or facility operators that generate electricity through an out of state resource recovery facility.

Be sure to choose the correct certification form for the type of generation facility, and to provide all supporting documentation specified on the applicable form. The certification forms, air permits, and other accompanying documentation must be mailed to the New Jersey State Board of Public Utilities at the following address:
