

## **ENHANCED INCENTIVES NOW AVAILABLE**

For Commercial and Industrial Customers, Local Governments and Municipalities

The New Jersey Board of Public Utilities and its *Clean Energy Program* are now offering enhanced incentives and/or program requirement modifications to increase participation and energy savings. Eligibility criteria is outlined below with specific information following regarding individual programs.

## NJ SmartStart Buildings Prescriptive/Custom Rebates

• Incentive rates are doubled for prescriptive equipment installed in existing building types listed below. Learn more.

## **Pay for Performance: Existing Buildings**

 Enhanced incentives equal to double of incentives #2 and #3, not to exceed 80% of project cost, are available for equipment installed in buildings listed below. Learn More.
