Pay for Performance

Pay for Performance (P4P) provides the opportunity to comprehensively improve the overall energy use and efficiency of your new construction project. Designed for larger buildings, the P4P program can help you achieve 5% more efficiency (15% for multifamily) than current energy code requirements.

SmartStart

Whether it's a new build or gut rehab, Smart Start is a great way to achieve savings through a list of prescribed measures for heating, cooling, lighting, and other projects. There is also a Custom Measure Plan for unique projects.

Combined Heat & Power

CHP systems provide efficient resiliency for health care facilities by generating electricity and useful heat simultaneously, providing much greater efficiency than generators alone. Maximum incentives up to 30% of project cost.

Hospitals designated as 501(c)(3) may be eligible for no-cost energy audits.
