

WARMAdvantage Program Furnace and Water Heater Rebate Application Instructions, Terms and Conditions

For Oil and Propane Customers

For Systems Purchased on or after August 1, 2015 through June 30, 2016

Instructions: Please read the program instructions, terms and conditions before completing the form on the other page.

A. CUSTOMERS – TO QUALIFY FOR YOUR REBATE, YOU MUST

- 1. Purchase, install and operate a high-efficiency furnace and/or water heater that meets or exceeds the minimum efficiency criteria as outlined below.
- 2. Replace and/or retrofit an installation in an existing New Jersey home that is currently supplied with oil or propane.
- 3. The efficiency levels are based on the ratings found at AHRI directory (AHRIdirectory.org), ENERGY STAR® listing (energystar.gov) or CEE-AHRI directory.
- 4. Abide by the rules and rebate levels in effect at the date of purchase.
- 5. All units must be purchased by June 30, 2016; however all applications must be postmarked within 60 days of the purchase date to be eligible.

- 1. Funding for this rebate program is provided through the United States Department of Energy State Energy Program (SEP).
- Due to the limited availability of funds, the program will terminate at the earlier of when funds are exhausted or June 30, 2016. Program termination will be posted on <u>NJCleanEnergy.com</u>.
- 3. Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
- 4. It is the responsibility of the customer to assure that all requirements for the rebate are met and that all required documentation is provided.
- 5. Failure to provide any of the required information will prevent processing of your application.
- 6. Rebate eligibility will be based on the equipment purchase date.
- 7. Incentives are available for the installation (retrofit) of qualified HVAC equipment in existing residential buildings; newly constructed home are not eligible.
- 8. Please allow up to 120 days from the date New Jersey's Clean Energy Program (NJCEP) receives all required information to process your rebate.
- 9. To expedite the processing of your application, please provide an AHRI reference number and or attach a copy of the AHRI spec sheet for the installed matched system.
- 10 If the customer portion of the rebate is to be assigned to another party, the customer must authorize this by completing and signing section B of the application form. 11. NJCEP reserves the right to inspect all installations in order to ensure compliance with all program requirements.
