- 1. I am the Director of Solar Energy for Public Service Electric and Gas Company ("PSE&G") and, as such, I am responsible for reporting to the Board of Public Utilities ("Board") status updates for the PSE&G's Solar 4 All Programs as approved by the Board in an Order Approving Stipulation, In The Matter of Petition of Public Service Electric and Gas Company For Approval of a Solar Generation Investment Program and Associated Cost Recovery Mechanism, dated August 3, 2009, under Docket Number E009020125.
- 2. I make this affidavit in support PSE&G's request for confidential treatment of portions of its Solar 4 All Monthly Activity Report ("report") that has been filed with the Board.
- 3. Project specific cost information, ("Confidential Information"), which the Board has requested be included in the report, is proprietary, commercially sensitive financial information. If this data were publicly available, PSE&G's competitors would have access to this commercially sensitive information. Access to this Competitive Information would provide these competitors with an informed understanding of how PSE&G bids for specific projects and potentially permit the competitors to develop strategies to gain an unfair advantage in the solar marketplace in which PSE&G participates.




